

Aug. 1: Senior Vice President of Policy and Advocacy **John Hryhorchuk** participated in a panel on environmental and natural resources law at the 36th Annual Texas Environmental Superconference for the State Bar of Texas in Austin.

Aug. 8: Senior Vice President of Strategy and Operations **Justin Coppedge** participated in a panel about water supply issues and how communities in Texas are tackling water availability challenges at an infrastructure summit hosted by the North Texas Commission and the city of Irving in Irving.

Aug. 9: Senior Policy Advisor **Jeremy Mazur** spoke to the East Texas Chamber Policy Committee regarding the need for a sustained funding strategy for addressing Texas' long-term water infrastructure challenges.

Aug. 20: Jeremy Mazur participated in a panel discussion with other water leaders on the importance of regional solutions for addressing water crises at the Deep South Texas State of Water Symposium in Pharr.

Aug. 20: Vice President of Data and Analytics **Dr. Holly Heard** hosted the quarterly meeting of Texas 2036's Research Advisory Committee, and welcomed Dr. Rabi Mohtar of Texas A&M to the group. Members provided insights on current research projects such as Classroom to Career and Justice-Involved Texans.

Aug. 23: Data Analyst **Carlos Navarro** spoke to the Asset Funders Network about Economic Mobility Data. Participants shared information on the metrics each is tracking related to economic opportunity.

Aug. 27: Policy Advisor **Emily Brizzolara-Dove** submitted written testimony to the House Human Services Committee in support of implementation of HB 1575, which will improve services and case management for pregnant women enrolled in Medicaid.
